Thank you for your interest in our Family Field Day to be held **Saturday, September 26**, rain or shine at Elkhorn Lake Hunt Club from **8:00 to 3 p.m.** This event allows families to try, on average between 8-10 different outdoor activities and ask questions of individuals that already are proficient in that activity. How better to know if you like something that to try it and ask the experts?



This year with the Covid-19 health situation we want each person and family to feel comfortable attending so we are asking everyone to **PLEASE** Pre-register so that we can assign groups before you arrive and not have to wait in line filling out paperwork. Walk ins will still be welcomed. We will not be requiring masks but leave it up to each individual and family to make the best choice for themselves. We will continue to watch and plan our event so that all our attendees and volunteers have a safe and enjoyable day. Parents or guardians are expected (required) to attend with their children, although older teens (15 and older) may attend with parental permission and signed liability waiver. (Suggested ages 8 and up) Bring a water bottle, bug spray, sunscreen and a hat, long pants and sturdy footwear to make yourself more comfortable. If you cannot swim, a life preserver is strongly suggested for around the pond area. All seminar equipment will be provided.

Scheduled activities and seminars will run throughout the day, and all sessions are attended by all participants. Events include:

- ☞ Fishing- catfish, blue gill and bass out of the pond.
- ☞ Archery Range - staffed by the Christian Bowhunters Association
- ☞ Shotgun- Elkhorn staff with help from qualified volunteers
- ☞ Rifle range - with supervision from our ODNR friends.

Additional activities may include:



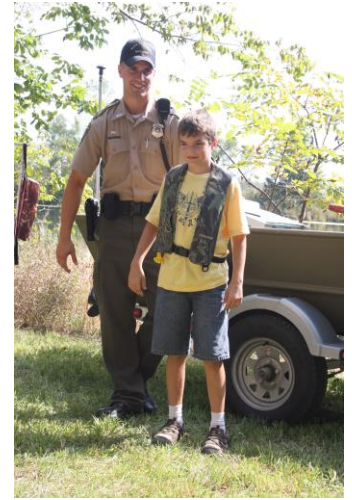
- ↪ Boat Safety (ODNR Division of Watercraft)
